ORDER

WHEREAS Nevada Iron Ltd. (the "Reporting Issuer") is a reporting issuer in Ontario;

AND WHEREAS the Director is of the opinion that it is in the public interest to make an order that trading in the securities of the Reporting Issuer cease;

IT IS ORDERED pursuant to paragraph 2 of subsection 127(1) and subsection 127(4.1) of the Act that, effective immediately, all trading in the securities of the Reporting Issuer, whether direct or indirect, shall cease until further order by the Director.
