Cease Trade Order

Affinity Mediaworks Corp. (formerly Green Bikes Rental Corporation)

Section 164 of the *Securities Act*, R.S.B.C. 1996, c. 418

- ¶ 1 Affinity Mediaworks Corp. (formerly Green Bikes Rental Corporation) (Affinity) is an OTC reporting issuer under BC Instrument 51-509 *Issuers Quoted in the U.S. Over-the-Counter Markets* (BCI 51-509).
- ¶ 2 Affinity has not filed:
1. interim financial statements for the financial periods ended October 31, 2008 and April 30, 2009, as required under Part 4 of National Instrument 51-102 *Continuous Disclosure Obligations* (NI 51-102),
 2. a comparative financial statement for its financial year ended January 31, 2009, as required under Part 4 of NI 51-102,
 3. a Form 51-102F1 *Management's Discussion and Analysis* for the periods ended October 31, 2008, January 31, 2009 and April 30, 2009, as required under Part 5 of NI 51-102,
 4. a Form 51-102F2 *Annual Information Form* for the year ended January 31, 2009, as required under Part 6 of NI 51-102,
 5. a copy of a news release and related material change report regarding:
 - (a) on January 7, 2009, effective January 22, 2009, the change of Affinity's name from Green Bikes Rental Corporation, increasing Affinity's authorized share capital to 200,000,000 common shares, and a 20 for 1 forward-split of Affinity's issued and outstanding common shares,
 - (b) on July 2, 2009, the appointment of Scott Cramer as Affinity's CEO and a director, and
 - (c) on July 9, 2009, the appointment of Kirk Shaw as Affinity's President,as required under Part 7 of NI 51-102,



6. a copy of each of the news releases that Affinity issued on April 23, 2009, May 12, 2009, May 15, 2009, June 2, 2009, June 23, 2009 and June 25, 2009, and related material change reports, as required under Part 7 of NI 51-102,
 7. a copy of the following documents that Affinity filed with the United States Securities and Exchange Commission (SEC):
 - (a) Form 8-K *Current Report* dated and filed January 30, 2009,
 - (b) Form 8-K *Current Report* dated and filed July 2, 2009, and
 - (c) Form 8-K *Current Report* dated July 9, 2009 and filed July 15, 2009,as required under section 11.1 of NI 51-102, and
 8. a copy of the Form S-1 *Registration Statement under the Securities Act of 1933* that Affinity filed with the SEC on April 30, 2008, as required under section 7 of BCI 51-509,

(the required records).
- ¶ 3 Under section 164(1) of the Act, the Executive Director orders that all trading in the securities of Affinity cease until:
1. it files the required records, completed in accordance with the Act and rules, and
 2. the Executive Director makes an order under section 171 of the Act revoking this order.
